The Wonder Year was a crucial moment in the Early Modern history of the Low Countries. After years of inquisition, fiscal oppression and bad harvests an iconoclastic fury exploded within the cities of Flanders and Brabant. It was a turning point of the history of this region, which was followed by the terror of Duke of Alba and beginning of the 80 years war.

The main goal of the 5th edition of Polish-Belgian workshop and symposium organized by the University of Antwerp and the Jagiellonian University was to discuss the Beeldenstorm of 1566 as a complex event with consequences on political ground, social relations and material culture.
